These proposed Regulations include a step-by-step introduction to the building application process; an Index, updated Zoning Map; a Zoning Districts Table showing density and dimensional standards applicable to land development in each of the Town's eight zoning districts; and a comprehensive Table of Allowed Uses that lists standards which apply to specified uses as allowed within one or more zoning districts.
