

# NOTICE OF PUBLIC HEARING

## NEW HAVEN TOWN PLAN UPDATE

The New Haven Planning Commission will hold an in-person public hearing on **Monday, May 11, 2026, at 7:00 PM (Correction)** at the New Haven Town Offices, 78 North Street, New Haven, Vermont, with a virtual option. This hearing is held pursuant to 24 V.S.A. 4350(b). ACRPC's Local Government Committee shall review New Haven's 2025 Town Plan to determine whether the Plan

- (1) is consistent with the goals established in 24 V.S.A. §4302;
- (2) is compatible with its regional plan;
- (3) is compatible with approved plans of other municipalities in the region;
- (4) contains all the elements included in 24 V.S.A. §4382

### Summary of Amendments:

- Element 2: A Land use Plan consisting of a map and statement of present and prospective land uses (pp. 37-38)
- A description of New Haven's forest blocks and land use goals related to forest blocks, and re-label Habitat Map to read "Forest Block Map" (pp. 29-32)
- Element 7: An Implementation Plan (pp. 49-51)
- Element 8: A Statement of Compatibility to indicate how the plan relates to development trends and plans for adjacent municipalities (pp. 4-5)
